Aurangabad - 431 136 hereinafter referred to as the "Endurance" (Which expression Shall , unless the context does not so admit , include its successor and permitted assigns), of the "OTHER PART "

- Endurance Group Desired to avail the service of Skill Jobs Services as Third Party Agency as per amended Apprenticeship Act 1961.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS :

- Skill Jobs Services shall support the mobilization activity to engage the mandatory Apprentices in Endurance Group of companies across India as per the requirement and parameters given by Endurance.
- Skill Jobs Services will facilitate for setting the curriculum, assessment and certification for apprenticeship training for optional trade.
- Skill Jobs Services will comply with the provisions of Apprentices Act 1961 and rules made there under. It will be the sole responsibility of Skill Jobs Services to make necessary compliances as per Apprenticeship Act 1961.
- Skill Jobs Services will organize basic training including practical training (if any) to the apprentices as prescribed for the trade.
- Skill Jobs Services will comply with required formalities for trade apprentice for appearing "All India Trade Test For Apprentices" as & when requires.
- The monthly attendance of the apprentices will be prepared jointly by Endurance and Team Plus. The same should be certified by the authorized Endurance official and accordingly Skill Jobs Services will ensure the payment of stipend of the apprentices.
- Skill Jobs Services will furnish all the returns on the portal site on behalf of the Endurance.
- Endurance will make necessary arrangement for training of apprentices as per Apprenticeship Act 1961. Endurance will abide all the rules & regulations of Apprenticeship Act 1961 and its amendments.

Monetary Aspects:

- Endurance will make a payment of stipend as per below :-

*Note : Attendance Bonus for Apprentice (App ITI)

- Attendance bonus @ 300/- pm will be given on min 23 days present -Rs 8710 +300 = Rs 9010.00.
- Attendance bonus @ 500/- pm will be given on min 25 days present - Rs 8710+500 = Rs 9210.00

***Note : Attendance Bonus for Apprentice (App BE)**

1. Attendance bonus @ 300/- pm will be given on min 23 days present -Rs 9500 +300 = Rs 9800.00
2. Attendance bonus @ 500/- pm will be given on min 25 days present - Rs 9500+500 = Rs 10,000.00

****Responsibility of timely re-imbursement of stipend will remain with Skill Jobs Services and ETL Plant HR.**

2. Endurance will pay to Skill Jobs Services Rs 675/- (Rs Six Hundred Seventy-five only) per month per student towards its professional service charges.
3. The Goods & Services Tax (GST) implementation by Central Govt would be as under:-
 - i. Skill Jobs Services has to provide a proper Invoice in the form and manner prescribed under rules of the GST Act (Tax Invoice, Credit and Debit Note Rules) containing all the particulars mentioned therein. In the event that the Skill Jobs Services fails to provide the Invoice in the form and manner prescribed under the GST Act (Tax Invoice, Credit and Debit Note Rules) the Company shall not be liable to make any payment against such Invoice.
 - ii. Skill Jobs Services has to ensure accurate reporting in Team Plus's outward supplies under GST. Further, that payments would not be processed in case of non-availability of ITC benefit to ETL due to lack of compliance by vendor (e.g. GST will be paid to the vendor only once the said amount is reflected as credit in the GSTR-2A and Skill Jobs Services has made payment of taxes to the Government Exchequer).
 - iii. Skill Jobs Services has to ensure that Invoice is raised within the time period prescribed in law for provision of services / supply of goods.
 - iv. In case of Skill Jobs Services default to comply with GST provisions, and ETL credit denied by the GSTN system, then ETL is authorized to recover the consequential costs such as interest / penalties, from Contractors by issuing Debit notes with GST.
 - v. On event of lower compliance rating at GSTN portal, ETL has full right to discontinue contract with pre-intimation.
 - vi. Skill Jobs Services has to ensure that tax benefits under GST law are passed on to ETL. In case of any liability on account of anti-profiteering provisions, supplier will be solely responsible and ETL will be authorized to receive the available benefit.
 - vii. Skill Jobs Services to note details of State wise GST Registrations of Endurance Group as under.

4. Endurance shall pay actual cost of Insurance premium of the Apprentices engaged by Skill Jobs Services and the said premium amount will be recovered from Team Plus.

5. Terms & conditions for Uniform, Shoes & Supervisor's charge will remain same as per the prevailing practice at Endurance.

Without the Endurance's prior written consent, Skill Jobs Services should ensure that its employees, agents and sub-contractors are bound by the provisions of this clause.

6. Validity period : This agreement will be valid wef 1st April 2018 to 31st March 2019.

7. Termination :

In the event there being a breach of any terms & conditions or covenants of this agreement by either of the parties, the party may terminate this agreement by giving 3 (three) months advance intimation.

In case of dispute the Court at Aurangabad would have the jurisdiction to deal with the matter.
